

## KQSR FM “MIX 100.9 NO REPEAT WORKDAY RULES”

The KQSR FM, hereafter “Station”, “MIX 100.9 No Repeat Workday”, hereafter “Contest” will begin Thursday April 1, 2021 and end on Thursday 12/30/2021.

To participate, listen weekdays between 9:00am and 5:00pm. Should Station play the exact same song, title and artist more than once, the first caller at 928-344-8090

A repeated song must be one that played earlier that same day within the time parameters specified and must play in its entirety for the money to be awarded.

There is only one winner a day during the guarantee.

The prize money will be awarded for the first song that is repeated. If multiple songs are repeated during a weekday, no additional money will be awarded.

Station will award the money after verification that a song has been repeated, and the 1st caller meets all eligibility restrictions.

***“Workday” is defined as 9 AM to 5 PM (MST) Monday, Tuesday, Wednesday, Thursday and Friday. To qualify for “NO REPEAT (Contest)” a song must play in its entirety and start no earlier than 9:00 AM (MST). To qualify for “NO REPEAT (Contest)” a song music play in its entirety and start no later than 4:59 PM (MST). \*\*\*if a song start time is “8:59:59 AM (MST) it will not be considered as a “NO REPEAT” song if that same song plays in its entirety between 9 AM to 5 PM (MST). A song start time of 4:59:59 PM WILL be considered a NO REPEAT SONG if that same song started and played in its entirety as proscribed by the official contest rules. Songs that start and play in their entirety at 5:00 PM or after will not be considered NO REPEAT songs.***

If the 1st caller does not meet eligibility restrictions, the next caller will be taken until the money is awarded.

Once a song is repeated during the designated time, listeners to Station have 10 minutes and 09 seconds from the end of the song, to be the 1st caller to 928-344-8090

Portions of songs that are featured in commercials, promos, sound bites and news clips are not considered a song that is repeated in the Contest guarantee.

A song must play in entirety from beginning to end to be considered one full play. Portions of a song are not considered a song that is repeated in the Contest guarantee.

The odds of winning money depend on the number of calls received each time a song is repeated.

## ELIGIBILITY RESTRICTIONS

A respondent to winning the Contest is open to legal residents 18 years of age and older and who reside in the Station's listening area. Employees and family members of El Dorado Broadcasters, LLC, participating retailers/sponsors, and employees of other radio stations in the YUMA/EL CENTRO area are not eligible to participate and win. Family members are defined as parents, children, spouses, in-laws, those in spouse-like relationships, and siblings (including those in step and half relations when living in the same household.) Anyone who has worked for or interned with El Dorado Broadcasters, LLC. is not eligible to participate or win.

You may only win the Contest once during the Contest dates.

One winner per household

If Station continues promoting the Contest as active after the contest dates in the rules have expired, these rules will automatically renew and for another year or until Station management cancels the contest.

### PRIZE:

“\$500.00 to each winner, meeting eligibility restrictions.

Prizes are non-transferable and will be awarded to the 1st caller responding to a song that is repeated during the Contest timeline and meets eligibility restrictions.

The Prize must be claimed in person by the winner and no one else. (SUBJECT TO CHANGE PENDING COVID RESTRICTIONS AT THE BEGINNING AND DURING THE CONTEST PERIOD)

### CONDITIONS:

Payment of all federal, state and local taxes are the sole responsibility of the winner. Winners will be reported to the IRS-on-IRS Form 1099 or the equivalent.

By participating in the Contest, the winners agree to allow their name, voice, and/or likeness to be used in any advertising or broadcasting material relating to this contest for a period of one year without any financial or other compensation.

The winners will be required to sign an Affidavit of Eligibility and a Receipt for Prize and Award upon acceptance of the prize.

Pursuant to the above-mentioned paperwork, the winners will agree to hold Station, El Dorado Broadcasters, LLC and the respective officers, shareholders, directors, employees, agents and representatives of each of them harmless from and against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.

All winners must be 18 years of age or older and must show proper identification and sign a prize receipt and publicity release prior to the acceptance of the prize.

Station, in its sole discretion, reserves the right to disqualify any person who is in violation of the rules.

The station further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.

These rules are subject to the interpretation of Station. Entrants are encouraged to listen to the station on-air. Station is not responsible for online streaming delays. Listeners in time zones outside of Arizona, MST are not eligible to participate.
